SECTION 4: First-Aid Measures

4.1. Description of first aid measures

Keep warm, calm and covered up. Never give anything by mouth to an unconscious person. In case of intoxication, call a poison control center or physician for treatment advice, taking the packaging or the label of the product. Symptoms of poisoning may occur even after several hours, continue medical observation for at least 48 hours after the accident.

If inhaled:

Immediate medical attention required. Remove the affected individual into fresh air and keep the person calm. If breathing is irregular or stopped, administer artificial respiration.

On skin contact:

If symptoms persist, seek medical advice. Remove contaminated clothing. Wash skin with soap and water, rinse abundantly. Do NOT use solvents or thinners.

On contact with eyes:

If symptoms persist, seek medical advice. Contact lenses should be removed. Hold eyelids open and flush with copious amounts of clean, fresh water or a special eyewash solution.

On ingestion:

Summon medical aid without delay. Do not induce vomiting due to aspiration hazard. Rinse mouth immediately with water. Keep at rest.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms: aspiration pneumonia, dazed state, skin irritation, dizziness, Information, i.e. additional information on symptoms and effects may be included in the GHS labeling phrases available in Section 2 and in the Toxicological assessments available in Section 11.

Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. 8.2. Exposure controls
